WHAT IS MY SERVICE?

My Service is an online menu accessible through all Kasikorn Securities channels, including the website, mobile applications like K-Cyber Trade and KS One.

In the **My Service** menu, there will be a topic menu

“Financial Transactions” which includes

- Deposit
- Withdrawal

- Sell Foreign Currencies

1 W-8BEN REGISTRATION

The W-8BEN application, required by the US Internal Revenue Service (IRS) for all foreign nationals with US income, enables a reduction of withholding tax on US market investments.

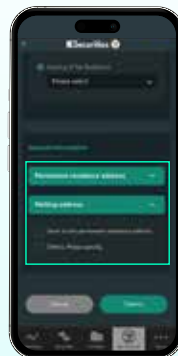
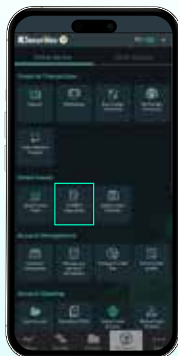
Clients who hold Thai citizenship will benefit from a reduction in dividend tax from 30 percent to 15 percent. For clients who are citizens of other countries, the dividend tax reduction will be determined based on the agreement between the U.S. Internal Revenue Service (IRS) and the client's country.

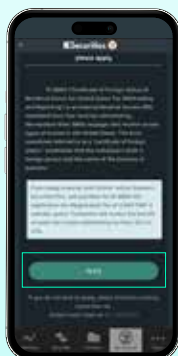

- 1 Go to the My Services menu and select W-8BEN Registration.
- 2 Fill in the information and check for accuracy. If correct, press OK.



- 3 Read and choose to accept the terms and press confirm.

How to deposit cash into your portfolio via KPLUS in real time

- 1 Login to KPLUS and select “Banking” menu.
- 2 Payment > search for 98269.

- 4 Fill in your trading account number (7 digits) and ID card/passport number.
- 5 Specify the amount you wish to deposit (you can deposit cash up to your approved credit limit. To increase your credit limit, please contact your Equity Wealth Manager.

3 BUY FOREIGN CURRENCY

Once funds are deposited into your investment portfolio, you can instantly convert them into foreign currency.

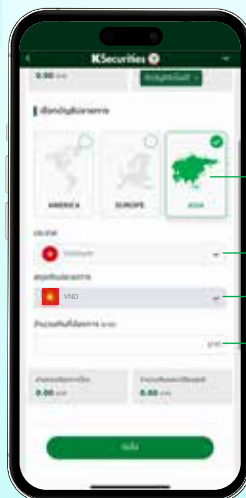

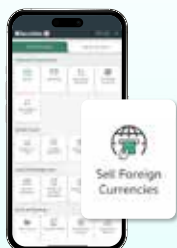
Selling currency is only permitted after the settlement date. If you place an order to purchase securities after requesting to sell currency, the company reserves the right to cancel the withdrawal request.

The exchange rate for converting the withdrawal back to baht will be the rate on the day the remittance is received from abroad.

The time it takes to receive the money is approximately 2–7 business days depending on the currency of each country and public holidays.

Please maintain the minimum balance required for each currency, as specified by the company in the guidelines below.

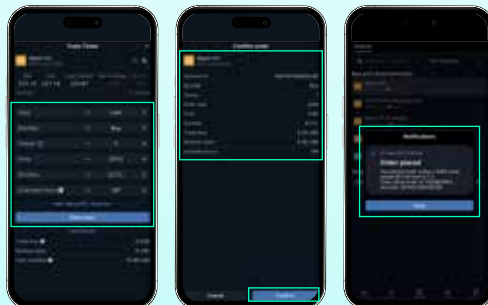
Trading Part displays watchlist names, price data, and order status.

4. **Charts:** A usable tool for technical analysis and contains multiple indicators for analysis.
5. **Screener:** A tool that filters stocks based on specific criteria.
6. **Price alerts:** Notifications that inform investors when a stock reaches a specified price level.

How to invest

1. Select [Trade] to place a buy/sell order.
2. Adjust the Order Type, Buy/Sell, and quantity to trade.
3. Select "Place Order" to submit, then "Confirm" to finalize or "Cancel" to discard.
4. A Notification will confirm the result.



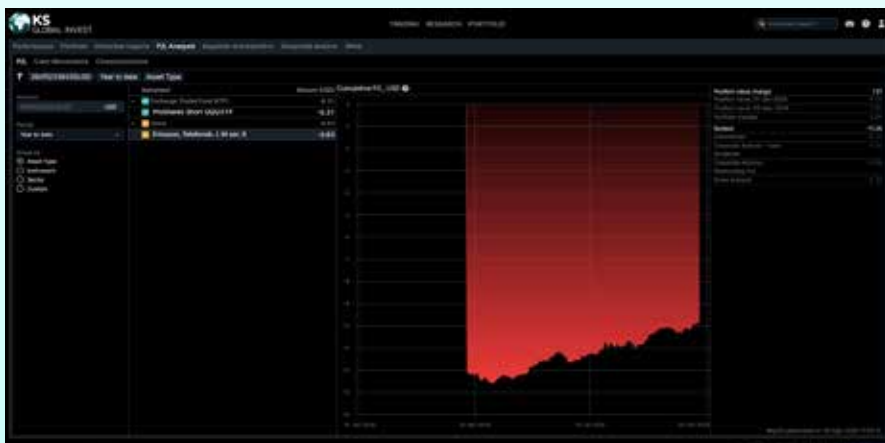

FREQUENTLY ASKED QUESTIONS

Q: Taxation from investing in foreign countries?

A: Start from 1 January 2024, In the case of gains (profits) from investments in foreign countries, if the profits are transferred back to Thailand, they must be included in the investor's income and reported to the Revenue Department.



Q: Customers can reduce US market dividend tax?

A: Clients who hold Thai citizenship will benefit from a reduction in dividend tax from 30 percent to 15 percent. For clients with citizenship in other countries, the reduction in dividend tax will be determined based on the agreement between the U.S. Internal Revenue Service (IRS) and the client's country.

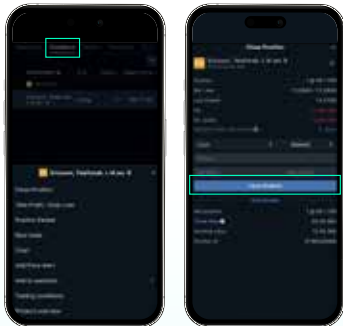

Order Type

Stop Limit	Similar to a regular stop order, but once the stop price is met, it converts to a limit order with a price you choose.
