

SET delists securities of POMPUI from being listed securities and allows trading during February 12 – 20, 2024 by purchasing with Cash Balance Account

The Stock Exchange of Thailand (SET) delists securities of KUANG PEI SAN FOOD PRODUCTS PUBLIC COMPANY LIMITED (POMPUI) from being listed securities according to clause 9 (6) (C) (D) and 9 (15) of SET's regulation Re: Delisting of securities B.E. 2542 (1999) due to negative shareholder's equity and the auditor did not express an opinion on the financial statements for the years 2004 - 2006. Although the company was able to amend the shareholders' equity to be positive and the auditor can express opinions on the financial statements, the company has been unable to repossess the qualifications in order to resume trading within specified deadline.

SET will allow trading on POMPUI's securities for 7 business days before the effective date of delisting, during February 12 - 20, 2024, under the following regulations and conditions:

- 1. POMPUI's securities are required to purchase through cash balance account which means that the investors have to pay the full amount in cash prior to purchasing.
- 2. NC sign will be posted during such trading period in order to alert the investors to be careful in trading securities.
- 3. The Ceiling and Floor prices of POMPUI 's securities on the first trading day (February 12, 2024)^{1/} will not be specified.
 - 4. Securities of POMPUI will be excluded from calculation of mai Index.

At the end of trading period (February 20, 2024), SET will delist the securities of POMPUI from listed securities, effective from February 21, 2024 onwards.

SET recommends shareholders and investors to trade POMPUI's securities with caution and carefully study information of the company such as financial positions, operating results, type of auditors' reports, major shareholders, board of directors, historical news as well as risks and other related factors. In addition, in order to provide service for the investors to access information, SET preliminary summarizes information of the latest financial statements together with type of auditor's report and the latest annual registration statements (Form 56-1 One Report) that the company disclosed via SET's disclosure system. The investors can study POMPUI's key information through the link in the following table.
