

SET delists the securities of IFEC and POST from being listed securities and allows trading during July 16 – July 25, 2024 by purchasing with Cash Balance Account

The Stock Exchange of Thailand (SET) delists securities of Inter Far East Energy Corporation Public Company Limited (IFEC) and Bangkok Post Public Company Limited (POST) from being listed securities due to such companies are unable to eliminate the grounds for delisting or to repossess the qualifications in order to resume trading within specified deadline which causes the grounds for delisting according to SET's regulation Re: Delisting of securities B.E. 2542 (1999). The grounds for delisting of each company are as follows:

SET will allow trading on the securities of IFEC and POST for 7 business days before the effective date of delisting, during July 16 - July 25, 2024, under the following regulations and conditions;

- 1. The securities of IFEC and POST are required to purchase through cash balance account which means that the investors have to pay the full amount in cash prior to purchasing.
 - 2. NC sign will be posted during such trading period in order to alert the investors to be careful in trading securities.
- 3. The Ceiling and Floor prices of securities of IFEC and POST on the first trading day (July 16, 2024)^{1/2} will not be specified.
 - 4. The securities of IFEC and POST will be excluded from calculation of SET Index.

At the end of trading period, SET will delist the securities of IFEC and POST from listed securities, effective from July 26, 2024 onwards.

SET recommends shareholders and investors to trade securities of IFEC and POST with caution and carefully study information of the companies such as financial positions, operating results, type of auditors' reports, major shareholders, board of directors, historical news as well as risks and other related factors. In addition, in order to provide service for the investors to access information, SET preliminary summarizes information of the latest financial statements together with type of auditor's report and the latest annual registration statements (Form 56-1) that the companies disclosed via SET's disclosure system. The investors can study the companies' key information through the link in the following table.

^{1/} In the event that there is no trading on securities of IFEC and POST on July 16, 2024, SET will not specify the Ceiling and Floor prices continuously until the trading of securities of IFEC and POST occurs. After the trading of securities of IFEC and POST occurs, the Ceiling and Floor prices will subsequently be adjusted according to normal criteria from the next working day.
